Puppies must be picked up on the agreed date unless otherwise arranged.

AKC registration paperwork, vaccination records, vet check documentation, and deworming schedule will be provided at the time of sale.

5. Shipping & Delivery:

If a puppy is to be delivered via pet nanny or air travel, additional fees will apply. These may include, but are not limited to, airfare, travel crate, health certificate, pet nanny service fees, and other associated costs. All shipping and delivery fees are handled on a case-by-case basis and must be paid in full prior to shipping. Please contact us directly to receive an accurate quote based on your location and delivery preferences.

6. HEALTH GUARANTEE

Buyer has 72 hours from the time of pickup to have the puppy examined by a licensed veterinarian.

If a serious health issue is diagnosed during this time and confirmed in writing by the vet, Seller will offer a partial refund or exchange at their discretion.

For confirmed genetic health issues diagnosed within 12 months of purchase, a partial refund may be offered depending on the situation and buyer's request.

7. BUYER OBLIGATIONS

Buyer agrees to provide proper nutrition, routine vaccinations, and regular veterinary care. Failure to meet these basic care requirements will void the one (1) year health guarantee. Buyer is encouraged to socialize and train the puppy to ensure good temperament and behavior.

Puppies are sold as pets only. Full breeding rights may be purchased at the time of sale for an additional \$500.

8. RETURN & REHOMING POLICY

Jewel of the Sandhills LLC does not accept returned puppies.

If the Buyer cannot keep the puppy, the Seller will assist in finding a suitable new home to minimize disruption to the puppy's well-being.

9. LEGAL TERMS

Disputes will first be addressed through direct communication and by referring to this contract.

If no resolution is reached, mediation will be considered before pursuing legal action.

This agreement is governed by the laws of South Carolina.

*** While the deposit is non-refundable under normal circumstances, an exception will be made if Jewel of the Sandhills LLC is unable to fulfill the obligation of providing a puppy from the*

agreed-upon litter. In such a case, the Buyer may choose to either transfer the deposit to a future litter or receive a full refund of the deposit amount.

**** In the case of a puppy being shipped to the Buyer, 100% of the total cost—including the puppy price, shipping supplies, airfare, veterinary fees, and any additional expenses—must be paid in full no later than two (2) weeks prior to the scheduled shipping date. Failure to do so may result in cancellation of shipping arrangements.*
